#### DEFINITIONS

#### CROATIA

<u>"Motorway"</u> is a public road specially constructed and reserved for the exclusive use of motor vehicles. It shall have two physically separated lanes (median reservation, safety fence etc.) for traffic flow in both directions with a minimum of two carriageways at least 3,5 m wide and also, depending on terrain configuration, an additional emergency lane which shall be a minimum of 2,5 wide.

Motorway shall not cross any road, railway line or tramway at the same level and access to the motorway is possible just on access and exit roads reserved for acceleration or slowing-down or on access barriers. Motorway ensures a safe traffic flow of the vehicles at a minimum speed of 80km/h and is marked as motorway by means of corresponding road sign,

<u>"A road reserved for motor vehicles only</u>" is a public road which shall have a minimum of two carriageways at least 3,25 m wide ensuring a traffic flow at a minimum speed of 60 km/h, where the traffic is reserved for motor vehicles only and as such shall be marked with a regulation road sign.

Regulations of the Republic of Croatia allow to build motorways in such a way that in the first phase of construction a motorway with only one carriageway, which shall be a minimum of 10,70 m wide, can be built.

Collecting of tolls is made according to category of vehicles as follows:

- 1. Vehicles having 2 axles whose height as measured at right angles to the front axle is no greater than 1,3 m except for minibuses
- 2. Vehicles having 3 axles or more, whose height as measured at right angles to the front axle is no greater than 1,3 m including minibuses
- 3. Vehicles having 2 or 3 axles whose height as measured at right angles to the front axle is greater than 1,3 m including minibuses with trailer
- 4. Vehicles having 4 or more axles whose height as measured at right angles to the front axle is greater than 1,3 m
